LEGAL BASIS

Article 6 of Regulation (EU) 2021/692

BUDGET LINE

07 06 03: Daphne

AMOUNT

EUR 417 301 in 2024, including EUR 67 135 pro-rata for 2023

DESCRIPTION

On 1 October 2023, the Council of Europe Convention on preventing and combating violence against women and domestic violence entered into force for the EU. The EU ratified the Convention through Council Decisions (EU) 2023/1075 and 2023/1076. The Convention has a monitoring mechanism composed of the Group of Experts on Violence against women (GREVIO) and the Committee of the Parties (CoP) which monitor the compliance of the contracting states with the standards set by the Convention. The monitoring mechanism is funded through the ordinary budget of the Council of Europe since the Convention does not contain a clause on financial contributions. As the European Union is not a member of the Council of Europe and, hence, does not contribute to the ordinary budget, the Council of Europe requested the EU to contribute to the costs of the Convention by paying a share of the Convention's annual budget. Given that combating violence against women and domestic violence is a priority for the European Union, an annual payment at a rate corresponding to that of a large contributor to the Council of Europe (DE, FR, IT, UK) seems appropriate. This contribution will be paid on a voluntary basis and should be without prejudice to the EU's financial contribution in other Council of Europe conventions.

1. INTRODUCTION

The actions for 2025 under the Work Programme of the Citizens, Equality, Rights and Values (CERV) programme continues to address the policy priorities set under its four strands as for 2023 and 2024. All horizontal principles, such as integrating gender equality and non-discrimination considerations in the design, implementation, monitoring and evaluation of all activities and financing actions with European added value remain applicable in the year 2025.

Similarly, the requirement that EU values based on Article 2 of the Treaty on European Union and the rights and principles enshrined in the Charter of Fundamental Rights of the European Union, particularly Article 21, are respected by all beneficiaries and activities implemented under this work programme also remains in force.

In addition to all the policy initiatives supported in the Work Programme for 2023-2025, which include initiatives to build a Union of Equality¹, the actions for 2025 support the recently adopted ‘Defence of Democracy package’², the EU Citizenship Package³, the Joint Communication on “No Place for Hate: a Europe united against hatred”⁴, the Directive on combating violence against women and domestic violence⁵ and the Recommendation on developing and strengthening integrated child protection systems in the best interests of the child⁶.

2. BUDGET OVERVIEW FOR 2025

Based on the objectives in Regulation (EU) 2021/692 of the European Parliament and of the Council establishing the Citizens, Equality, Rights and Values programme, this work programme presents the actions to be financed and the budget breakdown for 2025 as indicated in the table below.

with the support of international organisations, in compliance with the rules set out in the Financial Regulation.

Procurement is the acquisition of a service by the Commission from an economic operator⁷, selected following a 'call for tenders' procedure.

Grants are financial contributions by way of donation by the Commission in order to finance one of the following: (i) an action intended to help achieve an EU policy objective (action grants), or; (ii) the functioning of a body which has an objective forming part of, and supporting, an EU policy (operating grants)⁸. The award of a grant follows, in general, a call for proposals' procedure.

Under the indirect management mode, the Commission delegates budget implementation tasks to third entities to achieve a set of EU objectives.

Prizes are financial contributions given by the Commission as a reward following a contest. They promote the achievement of policy objectives of the Union⁹.

The Commission's Directorate-General for Justice and Consumers (DG JUST) will directly manage the implementation of actions, unless specified otherwise.

The implementation of actions under the specific objective to protect and promote the rights of persons with disabilities will be co-delegated to the Directorate-General for Employment, Social Affairs and Inclusion (DG EMPL, type I). The European Citizens' Initiative will be co-delegated to the Secretariat-General (SG, type I). A number of actions will be financed by the work programme by means of co-delegation type II and type III to: PMO (type III), DGT (type II), DIGIT (type II), ESTAT (type II), SCIC (type II), COMM (type II), GROW (type II).

The Commission delegates powers¹⁰ to implement actions in the Citizens' engagement and participation strand and the Union values strand to the European and Culture, Executive Agency (EACEA)¹¹. In addition, EUR 1 000 000 from the Equality, rights and gender equality strand will be co-delegated to EACEA for the call for proposals to enhance children's engagement and participation and children's rights.

EU Member States and third countries with which the EU has concluded an agreement participate in the Citizens, Equality, Rights and Values programme. However, as indicated in the CERV Regulation, the co-legislators explicitly excluded the participation of third countries in the Union values strand of the CERV programme. The list of non-EU countries that have concluded an agreement with the EU to participate in the programme is announced in the relevant call for proposals¹².

Activities implemented under this Work Programme shall ensure consistency, complementarity and synergies with activities supported by other Union instruments (including, in particular, those indicated in Annex I: Citizens, Equality, Rights and Values multiannual work programme for 2023-2025; Actions in 2023-2024).

3.1. Call for proposals to promote civil society organisations' awareness of, capacity building and implementation of the EU Charter of Fundamental Rights

LEGAL BASIS

Article 3 of Regulation (EU) 2021/692

BUDGET LINE

Budget line 07 06 04: Protect and promote Union values

OBJECTIVES

Protecting, promoting and raising awareness of rights and values by providing financial support to civil society organisations active at local, regional, national and transnational level in promoting and cultivating those rights, thereby also strengthening the protection and promotion of Union values and respect for the rule of law and contributing to the construction of a more democratic Union, democratic dialogue, transparency and good governance.

Building civil society organisations capacity and awareness on the EU Charter of

Fundamental Rights and carrying out activities to ensure that the Charter is upheld.

Policy initiatives supported: Strategy to strengthen the application of the Charter of Fundamental Rights in the EU, European democracy action plan, Recommendation on promoting the engagement and effective participation of citizens and civil society organisations in public policy making processes, Communication on ‘A more inclusive and protective Europe: extending the list of EU crimes to hate speech and hate crime’, Joint Communication ‘No Place for Hate: a Europe united against hatred’, Commission Communication on strengthening whistleblower protection at EU level, Rule of law reports, Commission Recommendation on protecting journalists and human rights defenders who engage in public participation from manifestly unfounded or abusive court proceedings (‘Strategic lawsuits against public participation’), the EU Citizenship Package.

TYPE OF APPLICANTS TARGETED

Civil Society Organisations (CSOs) active in promoting and protecting the rule of law, fundamental rights and democracy, as well as National Human Rights Institutions (NHRIs), equality bodies, ombuds institutions, public authorities from national, regional and local levels (if in partnership with CSOs).

POLICY PRIORITIES

Projects can be national or transnational. Transnational projects are particularly encouraged. In view of the overall objectives stipulated above, the call will support the following priorities:

1. Capacity building and awareness raising on the EU Charter of Fundamental Rights
2. Promoting rights and values by empowering the civic space
3. Strategic litigation
4. Protecting EU values and rights by combating hate crime and hate speech
5. Supporting an enabling environment for the protection of whistleblowers

EXPECTED RESULTS

1. Capacity building and awareness raising on the EU Charter of Fundamental Rights

- Increased awareness on and capacity to apply the Charter and the fundamental rights by CSOs, NHRIs, equality bodies, ombuds institutions, other human rights defenders, and Member State authorities from national, regional and local levels;
- Improved knowledge of available redress mechanisms under national and EU law, and how to make the best use of them for the benefit of rights holders;
- Improved cooperation between CSOs, NHRIs, equality bodies, ombuds institutions, other human rights defenders and Member State authorities from national, regional and local levels on fundamental rights issues.

2. Promoting rights and values by empowering the civic space

- Increased awareness on the situation of the civic space in the Member States based on sound evidence and comparable indicators;

- Strengthened cooperation and networks among the actors protecting the civic space at local, national and European level, including national and European authorities;
- Increased dialogue on the situation of the civic space, increased public attention to it, and the development of positive narratives on CSOs and human rights defenders protecting and promoting fundamental rights, rule of law and democracy;
- Increased protection of CSOs, their members and human rights defenders working in a safe environment;
- Increased reporting of attacks faced by the CSOs and human rights defenders and prompt and targeted responses to such attacks;
- Increased resilience of CSOs and human rights defenders against threats and attacks, including online.

3. Strategic litigation

- Increased awareness and knowledge by legal professionals and practitioners in CSOs, NHRIs, equality bodies, ombuds-institutions and other human rights defenders about EU law, including the Charter and its principles and articles, and the existing remedies and redress mechanisms to enforce these rights at national and European level;
- Increased ability of CSOs, NHRIs, equality bodies and ombuds institutions and other human rights defenders to develop a litigation strategy and communicate and advocate around it and to bring strategic litigation cases before national courts and the European Court of Justice;
- Increased awareness and knowledge by the general public of their rights under EU law, including the Charter, existing remedies and redress mechanisms to enforce these rights at national and European level, as well as awareness on and knowledge of the available support by legal professionals and practitioners;
- Strengthened abilities of legal professionals and practitioners to cooperate and engage in litigation practices to assist individuals in making effective use of available remedies to enforce their rights under EU law, including the Charter, before national and European courts;
- Increased awareness on the use of manifestly unfounded or abusive court proceedings against journalists and human rights defenders who engage in public participation (Strategic lawsuits against public participation (SLAPP));
- Improved knowledge on safeguards and protection against manifestly unfounded or abusive court proceedings for journalists and human rights defenders who engage in public participation.

4. Protecting EU values and rights by combating hate speech and hate crime

- Increased awareness about the societal effects of hate speech and hate crime, including more effective outreach to individuals and groups at risk of hate victimisation, thereby raising awareness of their rights, including all levels and in all types of education activities;
- Increased knowledge of EU and national hate crime and hate speech legislation and increased effectiveness of national actions to build the capacity of law enforcement

on detecting bias indicators and effectively investigating and prosecuting offenses.;

- More effective mechanisms and methodologies to report and record hate speech and hate crimes and to empower victims and witnesses to come forward;
- Enhanced assistance to victims to access specialist support, providing both victims and witnesses with emotional support, practical help and information;
- Increased effectiveness of mechanisms by online platforms to enable a prompt assessment and removal of hate speech content;
- Increased awareness among the general population about hate speech online, its “ecosystems” and its negative effects on democracy and pluralism;
- Enhanced resilience of civil society organisations to carry out their work against hateful groups and greater capacity to respond to hate attacks.

5. Supporting an enabling environment for the protection of whistleblowers

- More effective implementation of the national laws transposing the Directive on whistleblower protection, including by fostering increased awareness and understanding by the public, including by potential whistleblowers, of the procedures and rights provided under the Directive and better use of whistleblowing;
- Greater capacity to correctly apply the Directive’s rules for the private organisations and public entities concerned and for civil society organisations involved in the Directive’s implementation;
- Improved effectiveness and coherence of the Directive’s application;
- Improved cooperation between national authorities and CSOs, and between national authorities, in applying the Directive.

IMPLEMENTATION

Direct management by EACEA (co-delegation type II).

3.2. Call for proposals to promote equality and to fight against racism, xenophobia and all other forms of discrimination

LEGAL BASIS

Article 4 of Regulation (EU) 2021/692

BUDGET LINE

Budget line 07 06 01: Promote equality and rights

OBJECTIVES

Promoting equality and preventing and combating inequalities and discrimination on grounds of sex, racial or ethnic origin, religion or belief, disability, age or sexual orientation and respecting the principle of non-discrimination on the grounds provided for in Article 21 of the Charter.

Supporting, advancing and implementing comprehensive policies and an intersectional

approach to combat racism, xenophobia, antigypsyism, LGBTIQ-phobia, antisemitism, anti-Muslim racism and all forms of discrimination and intolerance.

Policy initiatives supported: the EU Anti-racism Action Plan (2020-2025), the LGBTIQ Equality Strategy (2020-2025), EU Strategy on combating antisemitism and fostering Jewish life, the EU Roma strategic framework for equality, inclusion and participation (2020-2030), EU Strategy on victims' rights, the Gender Equality Strategy (2020-2025).

TYPE OF APPLICANTS TARGETED

Member States and participating countries' public authorities, at all levels, equality bodies and civil society organisations.

POLICY PRIORITIES

Projects can be national or transnational. Transnational projects are particularly encouraged.

In view of the overall objectives stipulated above, the call will support the following priorities:

1. Fighting against discrimination and racism, xenophobia and other forms of intolerance, including antisemitism, antigypsyism as well as anti-black, anti-Asian and anti-Muslim racism
2. Promoting diversity management and inclusion at the workplace, both in the public and private sector
3. Fighting discrimination against LGBTIQ people and promoting LGBTIQ equality
4. Support to public authorities to combat racism, xenophobia, antisemitism, anti-Muslim racism, LGBTQ-phobia and all other forms of intolerance, including intersectional discrimination

EXPECTED RESULTS

1. Fighting against discrimination and racism, xenophobia and other forms of intolerance, including antisemitism, antigypsyism as well as anti-black, anti-Asian and anti-Muslim racism

- Increased knowledge of EU and national non-discrimination legislation;
- Improved knowledge and application of administrative practices in the non-discrimination field, including practices and policies covering multiple discrimination;
- Increased rights-awareness as well as awareness of biases and stereotypes;
- More effective implementation and enforcement of the legislation on non-discrimination, as well as improved independent monitoring and reporting;
- Improved understanding of racism and its different forms, including structural racism as well as increased knowledge on EU policies and legislation;
- Empowered and increased protection for groups, communities and individuals affected by manifestations of intolerance and racism, with a particular focus on antisemitism, antigypsyism as well as on anti-black, anti-Asian and anti-Muslim

racism;

- Improved knowledge and awareness of and capacity to react to all forms of racism among the population in general and key groups in particular such as decision-makers, law enforcement and judiciary, and young people;
- Increased knowledge on the recording and the collection of data on incidents, with a view of harmonising the methodologies across the EU.

2. Promoting diversity management and inclusion at the workplace, both in the public and private sector

- Increased number of organisations affiliated to a Diversity Charter;
- Increased knowledge and awareness on the benefits of diversity and inclusion at the workplace
- Increased diversity at the workplace, supported by stronger links between the academic and research community and the business world;
- More inclusive workplaces and societies;
- Increased and improved Europe-wide guidance and tools to build inclusive workplaces and to measure diversity and inclusion at the workplace.

3. Fighting discrimination against LGBTIQ people and promoting LGBTIQ equality

- Improved knowledge and awareness of the intersectional discrimination and inequality experienced by LGBTIQ people, in particular by transgender and intersex people, in employment, education and health, as well as solutions on how to tackle this;
- Increased awareness and improvement of skills of relevant professionals, including health, media, business and education professionals, to counter stereotyping, stigmatisation, pathologisation, discrimination, harassment and bullying affecting LGBTIQ people;
- Increased support for LGBTIQ people and their families, including through information campaigns, support groups, counselling and other means, and improved knowledge and awareness of the challenges they face;
- Better guidance for national authorities and education providers on how to prevent and combat school violence and bullying against LGBTIQ students, include positive representations of LGBTIQ diversity in education, tackle gender and sexuality stereotypes in education and accommodate the needs of transgender, intersex and non-binary children in educational settings.
- Improved data collection methods to better understand the needs and experiences of LGBTIQ people, informing evidence-based policies and interventions.

4. Support to public authorities to combat racism, xenophobia, antisemitism, anti-Muslim racism, LGBTQ-phobia and all other forms of intolerance, including intersectional discrimination

- Improved skills of public authorities to effectively investigate, prosecute and adequately sentence incidents of discrimination;
- Stronger cooperation between public authorities and civil society organisations that

collect data on incidents of discrimination;

- Improved support to victims, better public awareness of rights and increased number of reported incidents;
- Improved cooperation and exchange of information among public authorities (in particular municipal and regional administrations), as well as between public authorities and other actors such as civil society organisations and community representatives, to improve responses to discrimination, racism, xenophobia and other forms of intolerance;
- Improved knowledge and awareness among public and law enforcement authorities of the impact of discrimination, racism, xenophobia and other forms of intolerance and current trends, and better understanding of the various forms of intolerance and of the legal framework;
- Improved system of recording discrimination and collecting data, an improved methodological approach and better inter-institutional cooperation on data collection;
- Effective development and implementation of comprehensive frameworks, strategies or plans of action to prevent and combat, racism, antisemitism, xenophobia, LGBTIQ phobia and other forms of intolerance.

3.3. Call for proposals on European remembrance

LEGAL BASIS

Article 5 of Regulation (EU) 2021/692

BUDGET LINE

Budget line 07 06 02: Promote citizens' engagement and participation in the democratic life of the Union

OBJECTIVE

Supporting projects aimed at commemorating defining events in modern European history, including the causes and consequences of authoritarian and totalitarian regimes, slavery and colonialism, and the Holocaust, and at raising awareness among European citizens, of their common history, culture, cultural heritage and values, thereby enhancing their understanding of the Union, its origins, purpose, diversity and achievements and of the importance of mutual understanding and tolerance. Gender mainstreaming will be cross-cutting to all the priorities.

Policy initiatives supported: EU Strategy on combating antisemitism and fostering Jewish life 2021-2030, the EU Anti-racism Action Plan (2020-2025), the EU Roma strategic framework for equality, inclusion and participation (2020-2030), the LGBTIQ Equality Strategy (2020-2025), Guide to EU citizenship, Joint Communication 'No Place for Hate: a Europe united against hatred', the Gender Equality Strategy (2020-2025).

TYPE OF APPLICANTS TARGETED

Public authorities and bodies, civil society organisations, memorial and heritage sites, museums and archives centres, survivors' associations, and cultural, youth and research organisations educational and training providers.

POLICY PRIORITIES

Projects can be national or transnational. Transnational projects are particularly encouraged. In view of the overall objectives stipulated above, the call will support the following priorities:

1. Democratic transition, (re-)building and strengthening society based on the rule of law, democracy and fundamental rights
2. Strengthening the remembrance of the Holocaust, genocide, war crimes and crimes against humanity to reinforce democracy in the EU
3. Migration, de-colonisation, slavery and multicultural European societies

EXPECTED RESULTS

- Engagement of Europeans from different backgrounds – including young people and people who are multipliers (state administrators, law enforcement officials, members of the judiciary, policymakers, right-defenders, etc) in advocating, strengthening and supporting democratic institutions and structures based on the rule of law;
- Digitisation of historical material and testimonies of eyewitnesses for education and training purposes;

LEGAL BASIS

BUDGET LINE

Budget line 07 06 02: Promote citizens engagement and participation in the democratic life of the Union

OBJECTIVE

Promoting exchanges between citizens of different countries, in particular through town twinning, to give them practical experience of the wealth and diversity of the common heritage of the Union and to make them aware that these constitute the foundation for a common future

Policy initiatives supported: European democracy action plan, the EU Anti-racism Action Plan (2020-2025), the EU Roma strategic framework for equality, inclusion and participation (2020-2030), promoting diversity and inclusion (Diversity Charters), Strategy to strengthen the application of the Charter of Fundamental Rights in the EU, EU Citizenship Report 2020, the Gender Equality Strategy, the LGBTIQ Equality Strategy (2020-2025), the Strategy for the Rights of Persons with Disabilities (2021-2030), the EU Strategy on the rights of the child, the EU citizenship package, Recommendation on inclusive and resilient elections, as part of the 'Defence of Democracy package'.

Policy initiatives supported: European democracy action plan, the EU Roma strategic framework for equality, inclusion and participation (2020-2030), the EU Anti-racism Action Plan (2020-2025), the LGBTIQ Equality Strategy (2020-2025), the Strategy for the Rights of Persons with Disabilities (2021-2030), promoting diversity and inclusion (Diversity Charters), EU Citizenship Reports and the EU Citizenship Package, the Commission Recommendation on inclusive and resilient elections, the Commission Recommendation on promoting the engagement and effective participation of citizens and civil society organisations in public policy-making processes, the Gender Equality Strategy, the EU Strategy on the Rights of the Child.

3.8. Call for proposals to prevent and combat gender-based violence and violence against children

LEGAL BASIS

BUDGET LINE

Budget line 07 06 03: Daphne

OBJECTIVES

To fight violence, including gender-based violence and violence against children by:

- *Preventing and combating at all levels all forms of gender-based violence against women and girls in all their diversity and domestic violence, including by promoting the standards laid down in the Council of Europe Convention on preventing and combating violence against women and domestic violence;*
- *Preventing and combating all forms of violence against children, young people and other groups at risk, such as LGBTIQ persons and persons with disabilities;*
- *Supporting and protecting all direct and indirect victims of the forms of violence referred to in points (1) and (2), such as the victims of domestic violence perpetrated within the family or within intimate relationships, including children orphaned as a result of domestic crimes, and supporting and ensuring the same level of protection throughout the Union for victims of gender-based violence.*

Policy initiatives supported: the Gender Equality Strategy (2020-2025), the EU Strategy on the Rights of the Child, EU Strategy on victims' rights, the Council of Europe Convention on preventing and combating violence against women and domestic violence (Istanbul Convention) to which the EU acceded as of 1 October 2023, the Directive on combating violence against women and domestic violence, Victim's Rights Directive, Commission Recommendation on developing and strengthening integrated child protection systems in the best interests of the child¹³, Recommendation on harmful practices (planned for spring 2024), the LGBTIQ Equality Strategy (2020-2025), the EU Anti-racism Action Plan (2020-2025), the EU Roma strategic framework for equality, participation and inclusion (2020-2030).

TYPE OF APPLICANTS TARGETED

Member States' public authorities, support services, civil society organisations.

POLICY PRIORITIES

Projects can be national or transnational. Transnational projects are particularly encouraged.

In view of the overall objectives stipulated above, the call will support the following priorities:

1. Large-scale and long-term transnational actions on tackling gender-based violence
2. Targeted actions for the protection of and support for victims and survivors of gender-based violence and domestic violence
3. Targeted actions for the prevention of gender-based violence, including cyber violence

4. Targeted actions making integrated child protection systems work in practice

EXPECTED RESULTS

1. Large-scale and long-term transnational actions on tackling gender-based violence

- Roll-out of systemic changes through e.g. structural reforms, explicit commitments and changes of processes, protocols, policies and practices of organisations/companies/structures etc;
- Increased capacity of stakeholders and relevant professionals (including grassroots organisations and healthcare professionals) to address issues related to gender-based violence, including through strengthened multi-agency cooperation;
- As well as expected results mentioned for the other priorities below (corresponding to the form of gender-based violence addressed).

2. Targeted actions for the protection of and support for victims and survivors of gender-based violence and domestic violence

- Increased availability, accessibility and quality of victim support services, including those providing for targeted and integrated support for victims with specific needs, such as victims of sexual violence, victims of violence in close-relationships, providing for trauma support and counselling;
- Victims among persons in particularly vulnerable situations and groups at a heightened risk can better access protection and support services that address their specific needs;

- Strengthened multi-agency cooperation in relation to gender-based violence, including in cross-border situations;
- Strengthened victim protection including in cross-border cases of violence through the application of Directive 2011/99/EU on the European protection order.

3. Targeted actions for the prevention of gender-based violence, including cyber violence

- Increased promotion and support of prevention of gender-based violence through awareness raising, sharing of information and knowledge and the creation and dissemination of training opportunities;

- Increased awareness of prejudices, gender stereotypes and norms that contribute to the tolerance of gender-based violence;
- Increased awareness and engagement of men and boys in tackling gender-based violence against women;
- Increased capacity of stakeholders and relevant professionals to address issues related to gender-based violence including in relation to cyber violence and domestic violence;
- Increased empowerment of (potential) victims of violence to claim their rights and to stand up against violence;
- Changed attitude and behaviour as regards the issue of gender-based violence, including cyber violence (including lower tolerance and decreased victim-blaming):
 - among the general population and particular groups, e.g. relevant professionals, witnesses and bystanders, persons in vulnerable situations and groups at a heightened risk, etc.
 - among men and boys.
- Early signs of violence are detected and reported; increased reporting of violence to the police and other services, with appropriate mechanisms in place to facilitate this;
- Increased treatment of perpetrators of violence;
- Violence including online is prevented before it happens; reduced risk of violence escalating; increased safety of women and their children and others at risk from violence in close relationships and online violence.

4. Targeted actions making integrated child protection systems work in practice

- Strengthened integrated child protection systems;
- Strengthened prevention, protection and support to children suffering violence and in need of protection;
- Reinforced capacity of professionals to prevent, detect and respond to violence against children and child protection, including increased cooperation among relevant services.

Supporting the 2026 annual work programmes of framework partners.

Increasing the capacities of the framework partners to contribute actively to the development and implementation of EU policies in these areas.

Promoting equality and preventing and combating inequalities and discrimination based on sex, racial or ethnic origin, religion or belief, disability, age or sexual orientation and respecting the principle of non-discrimination on the grounds provided for in Article 21 of the Charter.

Supporting activities implemented in 2026-2028 by the European Network of the Equality Bodies, specifically for sharing experiences and good practices, trainings, awareness raising and studies.

Legal basis: Article 14(3) of Regulation (EU) 2021/692 of the European Parliament and of the Council establishing the Citizens, Equality, Rights and Values programme and Article 195(d) of the Financial Regulation.

POLICY PRIORITIES

EQUINET, the European Network of Equality Bodies, was created in 2007. Its members are the national bodies for the promotion of equal treatment created under: (i) Article 13 of the Racial Equality Directive 2000/43/EC, (ii) Article 12 of Directive 2004/113/EC on equal treatment between men and women in goods and services, (iii) Article 20 of Directive 2006/54/EC on equal treatment between men and women in employment, or (iv) Article 11 of Directive 2010/41/EU on equal treatment between men and women in self-employment. These provisions are expected to be replaced, as from May 2024, by two new directives on standards for equality bodies, requiring Member states to designate equality bodies to cover the grounds and fields of Directives 79/7/EEC, 2000/43/EC, 2000/78/EC, 2004/113/EC, 2006/54/EC, 2010/41/EU.

EQUINET can make use of the possibility to re-grant funds (i.e. financial support to third parties) to its network member organisations.

EXPECTED RESULTS

- Increased capacity of experts from national equality bodies to address issues related to non-discrimination and the implementation of EU legislation in the field;
- Strengthened cooperation and exchange of information between equality bodies;
- Improved knowledge of the legislation and administrative practices related to non-discrimination;
- Support to the transposition of recently adopted Directives and to the establishment of a list of indicators on the functioning of equality bodies.

IMPLEMENTATION

Direct management by DG JUST

3.12. Award of an operating grant without a call for proposals to EQUINET

LEGAL BASIS

Its members are the national bodies for the promotion of equal treatment created under: (i) Article 13 of the Racial Equality Directive 2000/43/EC, (ii) Article 12 of Directive 2004/113/EC on equal treatment between men and women in goods and services, (iii) Article 20 of Directive 2006/54/EC on equal treatment between men and women in employment, or (iv) Article 11 of Directive 2010/41/EU on equal treatment between men and women in self-employment. These provisions are expected to be replaced, as from May 2024, by two new directives on standards for equality bodies, requiring Member states to designate equality bodies to cover the grounds and fields of Directives 79/7/EEC, 2000/43/EC, 2000/78/EC, 2004/113/EC, 2006/54/EC, 2010/41/EU.

EQUINET can make use of the possibility to re-grant funds (i.e. financial support to third parties) to its network member organisations.

EXPECTED RESULTS

6. ACTIONS IMPLEMENTED IN INDIRECT MANAGEMENT

The budget reserved for indirect management actions is EUR 500 000 in 2025.

6.1. Support to the Council of Europe to boost its support to civil society organisations' knowledge and capacity to tackle hate speech online (phase 2)

IMPLEMENTING ENTITY

Council of Europe

OBJECTIVES PURSUED

The overall objective of the action is to further boost mobilisation of civil society organisations and other experts in undertaking effective responses to the societal challenges of hate speech online, to help foster resilient and pluralistic democracies. This action is the second phase of activities started under CERV work programme 2023-2024.

The action will enhance the training and capacity of civil society organisations in local contexts to cooperate with peers as well with public authorities on the use of counter narrative, education and awareness raising tools to tackle hate speech online.

The Council of Europe will work in the context of the activities of the High Level Group on combating hate speech and hate crime, in close cooperation with EU agencies, such as in particular the EU Agency for Fundamental Rights (FRA) to ensure synergies with the FRA-led Working Group on hate crime reporting, recording and data collection.

6.2. Support to the OSCE / ODIHR for knowledge sharing and standard setting on hate crime including hate crime victims support

IMPLEMENTING ENTITY

OSCE Office for Democratic Institutions and Human Rights (ODIHR)

OBJECTIVES PURSUED

This action aims to enhance the support to victims of hate speech and hate crime in the EU by sharing knowledge and good practices, supporting stakeholders on the ground, and developing standards and capacities on hate crime and hate crime victim support.

The OSCE / ODIHR will further intensify and develop dedicated work on standard setting and guidance on effective hate crime response and how to support hate crime victims in the EU. The project will be based on the previous Enhancing Stakeholder Awareness and Resources for Hate Crime Victim Support (EStAR) project, which developed practical tools to enhance the specialist support available, and victim support and criminal justice structures' responses to victims of hate crimes.

6.3. Support to UNESCO to combat Holocaust distortion (phase 2)

IMPLEMENTING ENTITY

UNESCO

OBJECTIVES PURSUED

The overall objective is to help combat Holocaust distortion and trivialisation. The results of the action will reach the general public, educators, media and stakeholders and inform them about how to recognise and counter Holocaust distortion and trivialisation. This action is the second phase of activities started under CERV work programme 2023-2024.

The concrete objectives of the Action are:

- To reach the general public on the danger of Holocaust distortion and trivialisation;
- To further train European educators, influencers, media, civil society organisations and stakeholders to recognise and counter Holocaust distortion and trivialisation.

7. Other expenditures

7.1. Experts

BUDGET LINE

Budget line 07 06 02: Promote citizens' engagement and participation in the democratic life of the Union

Budget line 07 06 04: Protect and promote Union values

AMOUNT

The budget reserved for other expenditures is EUR 450 000 under budget line 07 06 04: Protect and promote Union values and EUR 1 050 000 under budget line 07 06 02: Promote citizens engagement and participation in the democratic life of the Union.

DESCRIPTION

The Commission and/or EACEA may select external experts to assist in the evaluation of applications or the monitoring of actions. In particular, external experts with the relevant expertise, having the appropriate profile, as registered in the Funding & Tenders Portal Expert Database¹⁴, may assist the Evaluation Committees. Their tasks include, for instance, the evaluation of proposals following award criteria or of the operational capacity, drafting Individual Evaluation Reports or Consensus Reports.

AMOUNT

EUR 365 000 for 2025

DESCRIPTION

On 1 October 2023, the Council of Europe Convention on preventing and combating violence against women and domestic violence entered into force for the EU. The EU ratified the Convention through Council Decisions (EU) 2023/1075 and 2023/1076. The Convention has a monitoring mechanism composed of the Group of Experts on Violence against women (GREVIO) and the Committee of the Parties (CoP) which monitor the compliance of the contracting states with the standards set by the Convention. The monitoring mechanism is funded through the ordinary budget of the Council of Europe since the Convention does not contain a clause on financial contributions. As the European Union is not a member of the Council of Europe and, hence, does not contribute to the ordinary budget, the Council of Europe requested the EU to contribute to the costs of the Convention by paying a share of the Convention's annual budget. Given that combating violence against women and domestic violence is a priority for the European Union, an annual payment at a rate corresponding to that of a large contributor to the Council of Europe (DE, FR, IT, UK) seems appropriate. This contribution will be paid on a voluntary basis and should be without prejudice to the EU's financial contribution in other Council of Europe conventions.
